In the case of software reuse, however, it is unclear why an idea that has gained such universal acceptance was the source of swirling controversy when it began to be taken seriously by the software engineering community in the mid-1980's. From a purely conceptual point of view, the reuse of software designs and components promises nearly risk-free benefits to the developer. Virtually every model of software cost and development effort predicts first-order dependencies on either products size or the number of steps carried out in development. Reduce the amount of new product to be developed and the cost of producing the product decreases. Remove development steps, and total effort is reduced. By reusing previously developed engineering products the amount of new product and the number of development steps can be reduced. In this way, reuse clearly has a major influence on reducing total development cost and effort. This, of course, raises the issue of from whence the reused products arise.
